

Dear Iona Swim Club Bond Holders and Members,

Welcome to the 2013 season at Iona Swim Club! The Board of Directors has been working hard since the end of last season and we have exciting news. We purchased and are in the process of installing new filtration tanks. These tanks replace the original tanks from the early 1970's. We have also been discussing various activities to fill out our summer schedule such as: chalk art days, beef and BYOB night, family campout, fitness classes, swimming lessons, and evening splashes. Some of these activities may have small additional fees in order to offset costs that are not included in our operating budget. The additional money raised will be used to help maintain and preserve a safe, clean, and family friendly environment for everyone.

Work sessions have already begun to prepare for the upcoming season. During the first two weekends in February, several people worked to remove the old tanks and clean out the tank house to prepare for the new tank installation. Throughout March, April, and May, we will be having workdays to prepare the pool and grounds. These dates will be emailed as well as posted on both our Facebook page and website. All are welcome and encouraged to participate. In the past several years, we have been able to cut opening and preparation costs due to the help of our members.

Due to the installation of the new tanks as well as other pending updates, the Board has decided to increase dues for the season. Please review the following 2013 rate information. Remember, if you own a bond, you must pay the bond rate. Please send back your payment along with the registration form. Bonds are still available from the club. The 2013 pool rates are as follows:

Bondholder (Non-Senior)	\$275.00 If postmarked by 3/31	\$325.00 If postmarked 4/1 or later
Senior Bondholder (Bondholder 62 or older)	\$235.00 If postmarked by 3/31	\$275.00 If postmarked 4/1 of later
Single Membership	\$200.00	
Senior Single Membership (Age 62)	\$175.00	

Babysitting Fees:

Members who babysit children on a daily basis and would like to bring them to the pool	\$55.00/child for the season
Adding a babysitter to your bond	\$55.00/babysitter for the season

Children under the age of 12 MUST have an adult with them while they are at the pool. No children under the age of 12 may be left alone without an adult (someone 18 or older) at the pool. If it is discovered that a child under 12 is left alone without adult supervision, the parent will be contacted immediately to pick up their child.

Guest Fees:

Ages 5 and Under	Free
Ages 6-18	\$4.00
Ages 19 and Up	\$5.00

Guests MUST be accompanied by a pool member. Both the member and the guest will be required to sign in at the office before the guest can enter the pool area.

Private Parties:

Up to 25 people attending the party	\$55.00/hour
Over 25 people attending the party	\$75.00/hour

Parties can begin at 7 p.m. (the pool would be closed to members). Reservations to book private parties can be made with the guards. The pool would provide the appropriate number of guards.

Selling a Bond:

Bond members are required to pay the 2013 dues until they have sold their bond. Once the bond is sold, dues will be reimbursed. Reimbursement will be for the full amount if sold before the season begins. Once the season begins, the reimbursement is pro-rated. It is the responsibility of the bond owners to advertise and sell their bonds. Once the bond is sold and payment is received, email the name, address, phone number, and email address of the new bondholder to Kate at ionascmembership@gmail.com. We are reinstating the \$50.00 bond transfer fee (this fee is waived if the bond is purchased directly from the Iona Swim Club. *****According to the Iona Swim Club Bylaws: if you fail to pay your dues for the season, your bond will be null and void and will be forfeited back to the Iona Swim Club*****
